The Companies Act 2006 provides that a written resolution can be signed by the same majority as a resolution passed at a meeting, which is a simple majority for an ordinary resolution and 75% for a special resolution, whereas under the 1985 Act unanimity was required. However note that the written resolution procedure cannot be used to remove a director or an auditor from office.
